

**Movie Release – ALL TEAM MEMBERS MUST SIGN**

**What is this?** It's an agreement between you and CMF granting us rights to your movies.

**Why do I need to sign it?** We are thrilled to be able to offer you the equipment, software, technical support and everything else necessary to make a great movie for free. We want to be able to show your movie on the big screen and give away great prizes! But running CMF is expensive, and we help cover our costs by providing sponsors and advertisers the right to showcase the movies (it's also great exposure and publicity!).

**Will my team still get credit for creating the movie?** Absolutely. CMF will never take any creative credit for any aspect of the movie your team made. Period. Our ownership of the rights to your movie will never infringe on your team getting 100% of the credit for the movie's creation. It's a lot like a writer and a publisher – it's the writer's book and he or she receives all the credit for it - the publisher's rights are for things like licensing a paperback edition. Similarly, your movie will always be your creation and credit will be given to your team, but we will have rights like distributing and licensing your movie.

**Who needs to sign this Release?** Everyone who is involved in creating your movie – anyone who writes, directs, produces, edits, composes, etc. And, of course, all team members must sign, even if their contributions don't fall under the typical categories. In addition to this release, if you are an actor on camera or voice talent, you must also sign the Actor Release.

We, the undersigned, are the only members of the team listed below and the sole creators of the Materials (as defined below). In exchange for the opportunity to use equipment, software, and expertise of Ideas United, LLC ("IU"), as well as to participate in the Campus MovieFest event ("Event"), we grant to IU all rights and ownership in and to the Materials that our team creates and/or submits in connection with the Campus MovieFest Event.

The "Materials" shall mean any and all film, videotape and other audiovisual materials created by team members individually and/or collectively during the Event and/or otherwise submitted by our team to IU (or its designee) in connection with the Event, including any and all names, voices, likenesses, still photographs, graphics, artwork, music and sound recordings embodied in such film, videotape and/or audiovisual materials.

IU's exclusive rights shall include, but are not limited to, the right to use, adapt, reproduce, distribute, sell, license, exploit, publicly perform and/or display the Materials, or any portion of the Materials, throughout the world in perpetuity in any form or media now known or later developed, and the right to incorporate the Materials, or any portion of the Materials, into any compilation, advertisement, promotional material or any other form(s) that IU and/or its successors, licensees and assigns may elect.

We hereby give IU and its licensees, assigns, successors and designees the non-exclusive right to use our names, likenesses, voices and biographies in connection with any use of the Materials. We understand that IU shall not be obligated to use, distribute or exploit the Materials in any particular manner, or to continue using, distributing or exploiting the Materials.

Each person signing below represents and warrants that: he/she has the right to enter into this Release and to grant the rights granted to IU in this Release; the Materials are and will be created by the team collectively and/or by individual members of our team; the Materials are and will be either wholly original to me/us or in the public domain; and the Materials do not infringe or violate any rights of any kind or nature whatsoever of any person or entity. If we use or include in the Materials any materials that the team members did not create (such as photos, artwork, music, etc.), we represent and warrant that we have obtained written authorization for such use that gives us all rights needed to grant the rights in and to the Materials granted in this Release, including appropriate representations, warranties, and releases.

We hereby irrevocably waive any right to injunctive or other equitable relief in connection with this Release or any use of the Materials by IU and/or its successors, licensees and assigns. We hereby release IU and its successors, licensees, assigns, partners and contractors, and their respective employees, agents, directors, officers and representatives, from any and all claims we may have now or in the future, whether individually or as a team or otherwise, in connection with this Release and/or the Materials, including, without limitation, claims for invasion or privacy, right of publicity, monetary compensation, infringement, or any other cause of action that may arise out of any use of the Materials whatsoever, including but not limited to, reproduction, adaptation, distribution, sale, broadcast, performance, adaptation or display of the Materials.

By signing below, I represent and warrant that I am over the legal age of majority, and I acknowledge that I have read this Release and I understand and agree to all the terms contained in this Release. I understand that all references to "we" or "us" shall include me as an individual as well as the team collectively. This Release (together with any official Event rules, terms and conditions, etc.) constitutes my entire agreement with IU with respect to the Movie and the Event and may only be modified by a written agreement signed by IU and all Team members.
